What is **Autism**(or Autistic disorder)? A childhood disintegrative disorder; a neurological derangement that affects the functioning of the brain. When did **Autism** first appear in the U.S.? **Autism** was discovered in 1943, 12 years after the increase of the use of the Pertussis vaccine. One of the main components of the vaccine was the substance Thimerosal.(similarly in Europe and Japan in the 1950's after the increased use of vaccinations and thimerosal began).

What is Thimerosal? Ethyl **mercury**, a heavy metal, used as a preservative in vaccinations. According to the EPA and the CDC, if ingested in sufficient quantities can cause severe neurological damage. By body weight, a newborn should not be exposed to more than 0.5 mcg. Our babies are receiving up to 125 times the permitted safe dose...in one day!!! Unfortunately, if the toxicity of **mercury** weren't enough, other destructive adjuvants (additives) are mixed into the vaccination "cocktail" to further elicit an immune response. Toxic aluminum, formaldehyde, mycobacterium, pertussis bacteria, squalene and various other bacterial and mineral substances to name a few.

Despite the mountains of irrefutable evidence of the damage caused by Thimerosal alone, our medical/pharmaceutical monitors, the FDA CDC, NIH, AMA, HHS and even the American Academy of Pediatrics, never mandated the removal of Thimerosal. They made it a voluntary decision. Several states have actually outlawed the use of Thimerosal. Most manufacturers are phasing out the use of Thimerosal, only to have it included in all the flu vaccines now added to the list of childhood vaccinations beginning at 6 months old...countermanding the states' laws making its use illegal!!!

How common is **Autism**? Prior to 1943, **Autism** was extremely rare. Since the increase of compulsory vaccinations and booster shots(as many as 33 by their 2nd birthday), 1 in 150 children nationwide (1 in 94 in New Jersey) are diagnosed with **Autism** alone.

The medical/pharmaceutical cartel avoid categorizing the other diseases directly attributable to vaccinations with the figures for **Autism**: Diseases involving every body system; blood, lymphatic, digestive, cardiovascular, immune, neurological, respiratory and sensory: SIDS (DEATH), Guillain-Barré, Asperger's Syndrome, Reyes Syndrome, Palsy Syndromes, Juvenile Diabetes, Meningitis, Immune System Disorders, Chronic Bowel Disease (Celiac, Crohn's and IBS), ADD and ADHD Syndromes and all their variations.

Despite countless studies, anecdotal evidence, statistics, even Congressional testimony, the FDA, CDC, the AMA and the NIH, all mainstream medical publications refuse to admit the correlation between VACCINATIONS and **AUTISM** for fear of a tidal wave of lawsuits and the collective fury of families destroyed by our very own medical professionals. 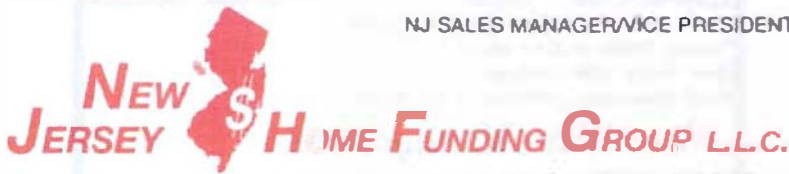
